

Required Care When Renting Skyline Grange

The Grange is a non-profit community resource maintained by volunteers. Please be respectful, responsible, and safe.

Alcohol

1. Alcohol is permitted under restricted conditions. Refer to these conditions in Section 3 of Terms & Conditions in "Skyline Grange Short Term Rental Agreement" and read more about OLCC regulations at https://www.oregon.gov/olcc/LIC/pages/special_event_licenses.aspx.

Benches

1. Vinyl Benches
 - They are stored in the Fish Storage Room.
 - They should be used only on the upper level and never outside.

Candles and Open Flames

1. You may use sterno in chafing dishes with constant supervision.
 - a. Open flames are not permitted without specific permission from the Grange. Special safety steps may be required.

Coffee Pots & Carafes

1. They are located in cabinet to the right of the refrigerator.
2. When finished, wash them thoroughly.
3. Position carafes upside down to dry. Grange volunteers will put them away.
4. To dry electric coffee pots, air dry with filter basket and water lid open. Grange volunteers will put them away.

Damages

1. Please report maintenance problems or damages that you find prior to your use of the premises.
2. Please report any damages that have occurred during your use of the premises.

Decorations & Displays

Do NOT use tape (except Painter's Tape), nails, glue, or screws to hang decorations or displays on walls, doors, acoustic panels, ceilings, floors, or furniture. Pins are permitted to mount light weight items on acoustic panels. No glitter, confetti or rice are allowed anywhere on the property, inside or out. (Birdseed is permitted.)

Fans

1. The overhead fans are sometimes necessary in the summer. They are controlled by a labeled switch in the lower level kitchen between the refrigerator and the side door.
2. Don't let escaped balloons tangle in the fans.

Fields

1. Our fields are not lawns. They are uneven and may have occasional critter holes. We try to keep our fields clear and mowed, but there may be branches or other natural debris in them. Be cautious when walking and definitely while running in them.
2. There should absolutely be no entrance to areas surrounded by wooden fences.

3. During the wet months, do NOT drive any vehicles onto the fields. You will rut up the fields and probably get stuck and you will be liable to repair these damages. During the wet months don't even attempt to drive around the building to access the Lower Level of the building.

Floor Care

Main Level

The flooring on the upper level is new. We worked hard for this improvement. Please take special care of the flooring.

1. Do not drag tables and chairs across the floor. Pick them up!!
2. Have attendees wear proper footwear – no stiletto high heels, no mud, dirt, abrasive or sticky substances on shoes.
3. Promptly clean up spills.
4. Protect flooring from abrasives, pebbles, grit, sand, sharp objects, chemicals, or anything that would stain it.
5. Sweep or vacuum well after use and before mopping.
6. Mop using a solution of Zep Neutral Floor Cleaner.
 - a. The cleaning solution, directions, mops, & bucket are located on lower level in Cleaning Supply Storage Room.
 - b. If only a few spots need cleaning, you can use the spray bottle of Zep Neutral Floor Cleaner located in the Fish Storage Room.
 - c. Do not use cleaning agent other than Zep Neutral Cleaner – NO Simple Green, Lysol or Windex, etc.

Lower Level

1. Vacuum or sweep thoroughly, then mop using a Simple Green solution.

Furnace

1. The furnace heats the place quickly.
2. Make sure the floor vents are open if heating the main hall.
3. If you want some heat in the Lower Level, make sure the ceiling vents are open.
4. We have no air conditioning.
5. When it is cold outside, keep the doors closed as much as possible.

Garbage

1. Take all trash, garbage, and recyclable items with you.
2. The Grange does not have garbage service.

Hours of Use & Noise Restrictions

1. Grange is open for use between 8 a.m. and midnight.
2. No occupation of the premises is allowed between midnight and 8 a.m., even for Users renting the Grange for a weekend without special permission.
3. Music and any other loud noise must end promptly by 9 p.m. out of respect to neighbors.
4. The parking lot must be cleared of attendees no later than 10 p.m., though quiet clean-up crew can work until midnight after which the premises must be vacated for the night.
5. Our noise/music/hours policies and the Portland City Noise Ordinance **will be enforced** and neighbors may call police if necessary.

Keys

1. Immediately put the key back into the lock box after opening the door.
2. Never take the key off the Premises.

3. Do not give the key box code to any unauthorized person.
4. If key is lost you will be charged for a locksmith or key replacement.

Lights

1. For Front Entry & Foyer Areas
 - a. Light switches are to the left of the front door as you enter.
2. In Main Hall
 - a. For ceiling lights, switches are to the left of the inner double doors.
 - b. For lights in the alcove area of the Main Hall, switches are on the left in the alcove area.
3. For the Lower Level Kitchen, Above Kitchen Sink, and Meeting Areas
 - a. Switches are on the right at the bottom of the stairs.
4. For Restrooms & Cleaning Supply Room
 - a. Switch is on wall between the refrigerator and side door.

Parking

1. Do NOT park in the fields when fields are wet or even dewy. You will get stuck easily.
2. Our parking lot holds about 40 efficiently parked vehicles. You might want to designate someone (with a bright orange vest) to direct parking if you expect a lot of vehicles.

Phone and Internet

1. Grange does not have telephone service. Users should have a working cell phone while on premises in case of emergency.
2. Grange internet will only be allowed with special permission. Additional fees may be charged.

Rags

1. There is a bin of rags in the Cleaning Supply Room on the Lower Level. Please use them for messy jobs instead of the dishcloths in the kitchen that are located in the cabinet across from the sink.
2. Hang wet, dirty rags to dry. Grange volunteers will wash them.

Restricted Areas

1. To protect our septic system, do NOT enter the two areas surrounded by wooden fencing – one is located in the field to the right of the building and the other is behind the building.
2. There are a number of doors and cabinets that are clearly marked “**For Grange use only.**” Please be respectful and not enter or use them.
3. Skyline Grange wooded areas are not for renter use.

Restrooms

1. Restrooms are accessible only by stairs, and thus are not handicapped accessible.
2. We are on a septic system that needs special care.
 - Do NOT put anything down the toilets except for human waste and moderate amounts of toilet paper.
 - Dispose of women’s hygiene products, diapers, paper towels, etc. in a wastebasket.

Smoking

1. Absolutely no smoking inside the-Grange.
2. This includes cigarettes, cigars, e-cigarettes, and marijuana.
3. Tobacco use is permitted outside only in a designated area.
4. Do not toss butts on the ground. Use specified receptacle.

Tables

1. Do NOT drag over floor. Pick up and carry.
2. Use table protection, such as paper or a tablecloth. {There are about 5 basic plastic tablecloths in bin above the stored tables in the User's Supply Room. If you use these tablecloths, wipe clean when finished and then drape over tables to air dry. Grange volunteers will put them away.
3. Wash tables off with soap and water.
